# LETTER FROM THE EXECUTIVE DIRECTOR



### To Our CASA Friends and Supporters,

As we reflect back on 2021, it was another challenging time across the Commonwealth. It's sad to share that for the third consecutive year, Kentucky has been ranked number one in abuse and neglect; Hardin County continues to see a surge in cases as well. In fact, since the May/June timeframe, we've gone from 43 children on a wait list for a CASA volunteer to 105, and we unfortunately do not see an end in sight for rising numbers for 2022.

Continuous program challenges caused us to focus on unknown demands as we all dealt with a world-wide pandemic. With COVID, our in-person events were cancelled and some key grants were cut by 50% since the pandemic start. Yet, through your support with us,

we were able to meet all the challenges that come our way and we still served children who relied on us to be there for them.

We worked with 57 CASA volunteers who completed 434 child visits and 952 training hours all of which were focused on serving 160 vulnerable children here in Hardin County.

Based on our CASA volunteer recommendations, many children received critical physical and mental therapeutic services; while a total of 50 children went to permanent, safe and loving homes.

We are also pleased to share that besides our regular day-to-day critical advocacy, we were able to distribute new coats, hats, gloves, toys, journals and other games to vulnerable CASA children all with the outreach and support of many community partners and supporters including you.

There's much more work to do in 2022, but with you as a supporter, we will be able to provide advocates for those waiting on us to be their voice when often they don't feel they have one. Being a CASA volunteer changes a child's story and we are honored to do this work each and every day.

# SUCCESS STORY: CASA IN ACTION

A precocious brother-sister duo were removed from their Natural Parents and immediately placed with loving foster parents, who only after a few weeks had the pair adjusting to their new environment. The children's CASA volunteer entered into their lives several months later. The CASA volunteer quickly



grew attached to the children and was eager to help them navigate the rest of their journey to permanency; the next 6 months were spent working through this process. The foster parents were not a concurrent home, meaning they weren't open to adopting the children. The Cabinet for Health and Family Services began looking for a new placement that would be a permanent placement for the two siblings. After 23 months with their first foster family, they were moved to their second foster home. The children still see their first foster parents from time to time. During this time, the CASA volunteer advocated on the children's behalf by communicating with



social workers, teachers, foster parents, and the court. As more time passed the court began shifting toward getting the children adopted. After 38 months in care, the children were adopted by their second foster parents. Despite the changes this duo encountered, their CASA volunteer was a consistent, loving adult who listened and cared about whatever

they had to say. They're now in a loving home where they know their parents love them and they feel safe. Given the circumstances, what more could one ask for!
